



Player's Club Membership Agreement

Golf Practice Facility

General

1. The following terms and conditions are agreed to by the member named at the bottom of page 2 and Valley Golf Center (VGC). Members understand that the East Section of the facility is reserved for the exclusive use of the members of the Player's Club. The East tee and practice area will be maintained to a higher standard than the public tee and practice area. We ask that you as Members, care for this area as if it were your own, and report any damage being done by anyone else.
2. The East Section, also known as the Player's Club, **is Irons Only. This is NON NEGOTIABLE.** It is mandated by the County of Madera, as part of our conditional use permit, that drivers not be permitted in this section. Members must agree to and abide by this rule. Failure to do so, may cause your membership to be revoked and you may be responsible for any damages caused by violating this condition.

3. Members will be required to check-in with the Pro Shop when they arrive. This will help VGC staff monitor the private area that you are paying for.
4. While we keep this section on grass as much as possible, there may be times during maintenance or inclement weather that grass will be unavailable.
5. The far end of the East Tee is our Teaching Section. It is reserved for the Valley Golf Center Teaching Staff Only.
6. Valley Golf Center's Staff is allowed to practice in the member's area. However, if the member's section is full or busy, they will be required to practice elsewhere.

Staff

1. Valley Golf Center's Staff has been directed to respectively enforce the rules as they are presented in this agreement. *Please comply and cooperate with our Staff.*

East Section - Short Game Practice Area

1. Practice balls will be provided to members for their use only, at no charge. Please do not hit these balls into the driving range.
2. Bump and run shots are permitted on the putting green. Please fix and repair any damage and/or dents that you create. For the safety of others, please don't practice these shots if the green is busy with other members.

3. Pitch and lob shots are permitted on the practice pitching green ONLY.

Non-Member Use of Player's Club

1. As a courtesy, Valley Golf Center, extends the use of the practice short game area to select entities such as the Fresno State Golf Programs. Every effort will be made to minimize impact on our members.
2. Special Event days may require use of the Player's Club section. VGC will attempt to provide adequate notice in advance of these dates.
3. If you see anyone disrupting or damaging the Player's Club section, please advise a member of the Valley Golf Center Staff.

Additional Benefits

Training

1. Valley Golf Center will provide 4 Free Clinics per year from our Teaching Professionals. These dates will be published, and will allow for adequate time to sign up.

Membership

1. This is a monthly membership. Membership may be suspended or terminated for non-payment of dues.
2. You will be issued a Membership Card.
3. You're required to check in with the Pro Shop Staff prior to practice. Be sure to have your membership card available at check in.
4. Any membership card being used by anyone other than the member named on the membership card, will result in immediate termination your membership.
5. There is a \$5 fee to replace lost or stolen membership cards.
6. You **must come into the Pro Shop and turn in your membership card to temporarily freeze your membership. Your membership will be reinstated when you pick up your membership card.**

I understand and agree to the terms set forth above. I also understand that failure to abide by the terms and conditions contained herein, will result in suspension and possible termination of my membership privileges. Monthly dues are paid in advance. Dues *will NOT* be refunded in the event of a temporary freeze, suspension, or termination of membership privileges.
